# **EDUCATIONAL PROJECTS**

2016-2017 (CSU-Pueblo): I set up a crowdfunding website on gofundme.com and collaborated with several academic departments in order to invite filmmaker Joshua Munson to campus. He

directed a narrative film, titled *Black Coffee*, working with over 80 students, who were involved with technical work, acting, postproduction, composing the score, etc. Munson also led a hands-on workshop on campus to teach students about being a cinematographer. My own students, in a special topics "Filming Philosophy" course, were required to be involved in the filmmaking process and to write about their experiences in relation to our course content. Communications and Art students also participated in the project as part of academic courses.

2015-2016 (CSU-Pueblo): I worked with Professor Caroline Peters from the Art Department to organize and raise funds for a series of events. We invited two international visual and performance artist to our campus – Luke Turner and Nastja Säde Rönkkö. The two artists gave a public lecture and held an exhibition of their work at the CSU-Pueblo Fine Art gallery. I also presented a public lecture, relating the artists' work to philosophical problems involving authorship and group cognition. Numerous courses across disciplines (Art, English, and Philosophy) visited the exhibition or assigned students work related to it.

2014-2015 (Kutztown University): I was the Principal Investigator of two grants received from the Kutztown University Foundation and the Kutztown University Professional Development Committee totally \$5,440. With these grants, I (the Philosophy Department) invited three presenters to KU. The first was a theatrical actor, Bill George, who performed, for the university community, a one-man show based on Thoreau's *Walden*. He also performed short excerpts for Philosophy, English, and Geography courses. The second two presenters were external lecturers who spoke about Thoreau's work in relation to nature and environmental ethics. I invited Dr. Philip Cafaro of Colorado State University and Dr. Edward F. Mooney of Syracuse University.
